FRCB volunteers work hard to make sure the Rockville Civic Ballet (RCB) and its artists and programs have the funds and resources they need for giving back the best possible performances, for creating new works and preserving the existing repertoire, and for offering opportunity to, while welcoming participation by, the Rockville area's unique, inclusive and diverse community of those who love the Art of Dance.

Please note: No dancer is required to join the FRCB to participate in RCB shows.

HIGHLIGHTS OF OUR PREMIER YEAR

Friends of the Rockville Civic Ballet (FRCB) began 2017 as just an idea. A great idea with no money but lots of enthusiasm. Our first action was to become an incorporated entity in Maryland. There was an initial outlay of funds that came from a small and committed group involved in filing Articles of Incorporation. Once FRCB was incorporated, the next step was to apply for 501(c)(3) status as a non-profit with the Internal Revenue Service. This application was submitted on 28 April 2017 and, from that date forward, FRCB has been able to accept tax-deductible donations. A significant contribution was made by private individuals to launch an endowment to support an effective and productive future for the Friends of the Rockville Civic Ballet.

Operating Highlights

Articles of Incorporation and Bylaws were submitted to the State of Maryland to establish the FRCB organization.

An application for 501(c)(3) status was submitted to the Internal Revenue Service.

A provisional Board of Directors was established with all officers serving as volunteers.

Fundraising from members, public contributions, and GoFundMe raised \$7642.

Fundraising from direct retail sales (crafts, flowers, t-shirts, bake sale) raised \$4682.

An Alumni Reunion Event was held in December 2017, bringing together many former dancers and their families.

The FRCB web site launched in October of 2017. Our new Facebook page is now active.

Treasurer's Report

Friends of the Rockville Civic Ballet follows on the amazing spirit and accomplishments of committed dancers, families and friends who crafted a framework of support and financial aid for the Rockville Civic Ballet

over 40 years. Our gratitude goes out to those who contributed for costumes and sets through bake sales, flower sales, craft sales and tireless sewing.

Our goal as a non-profit is to broaden the capacity of the Rockville community to support the Art of Dance that is the Rockville Civic Ballet. FRCB was formed in partnership with the City of Rockville, Department of Recreation and Parks and the legacy of Claudia Mangan, founder of the Rockville Civic Ballet. The FRCB mission is one of a diverse and inclusive organization.

FRCB was launched financially on 3 May 2017 by opening our checking account. We thank Bill Wood for contributing approximately \$2000, including funds raised by Claudia Mangan to enhance and support the Rockville Civic Ballet. Our finances were strengthened with designated contributions for new sets and stage pieces, the sale of FRCB-branded merchandise and an endowment account. Total revenue for 2017 was \$17,620. After expenses and startup costs, FRCB ended 2017 with an increase in net assets of \$8427.

Funds were raised from a variety of sources within the Rockville Civic Ballet community, including alumni, friends and current families as well as sales proceeds during each performance. As with the RCB in years past, most funds were raised during the six *Nutcracker* performances.

FRCB focused our sights in 2017 on replacement of Nutcracker sets damaged

by water in 2015. Funds were raised online through GoFundMe, a series of benefit concerts hosted and presented by the Tennant family specifically for this purpose, and direct contributions. FRCB was able to secure the services of a carpenter who did major rebuilding design and produced manuals for care and assembly for \$2500. An in-kind contribution from Home Depot is gratefully acknowledged. The "sweat equity" of committed volunteers provided the finishing touches enjoyed by our audiences of many hundreds of children, families and Friends of the Rockville Civic Ballet.

Accounts

FRCB has a Federal Employer Identification Number: 82-1085137

FRCB holds checking and no-fee savings accounts at Capital One Bank.

Protocols have been established for accepting credit card transactions, for accepting & processing cash advances, or for purchase of materials and supplies to support sales during ballet performances.

Current Priorities

Sustainability – having a vision and strategic plan for long-term growth and meeting our mission statement.

Expanded community presence and visibility consistent with mission as diverse & inclusive.

Membership drive to include as many RCB families as possible.

Emphasize building up our endowment.

Notes to the Financial Statements

STATUS AND PURPOSE OF FRIENDS OF ROCKVILLE CIVIC BALLET

Friends of Rockville Civic Ballet, Inc. (FRCB) is a 501(c)(3)-qualified organization incorporated in the State of Maryland dedicated to supporting the artistic leadership of the Rockville Civic Ballet, a community-based performing company of volunteer dancers under the jurisdiction of the City of Rockville Department of Recrea-

tion and Parks. The Rockville Civic Ballet performs three classical ballet productions each year in Rockville's F. Scott Fitzgerald Theatre, with ten shows for which tickets are sold, including six performances of *The Nutcracker* annually. Founded in 1975 by Claudia Mangan, the Rockville Civic Ballet has been directed by Eleanor Simpson since 2015.

During the 2017 Fiscal Year, the FRCB had no debt and held assets only in cash. This means that only Current Assets only are shown since there are no fixed assets, depreciation or amortization. The FRCB has no employees. Board members, officers, committee members and other participants are volunteers, so no direct or indirect labor expenses are shown.

Sources of Funds

INCOME SUMMARY

During Fiscal 2017 the FRCB generated gross income of \$13,041. Unrestricted gross income was \$12,541, including unrestricted contributions to the FRCB of \$7142, or 56.9%. A \$500 contribution is donor-restricted.

MEMBERSHIP FEES

FRCB is supported by a membership that pays annual fees which totaled \$715 in Fiscal 2017, comprising 5.7% of unrestricted gross income. During 2017, the FRCB membership comprised nine individuals, 21 fami-


lies and two alumna who are former dancers continuing to support the Rockville Civic Ballet. Members are entitled to attend general membership meetings, vote in FRCB elections, serve as board members or participate as volunteers in FRCB projects.



LOBBY SALES

After the Spring Show of the Rockville Civic Ballet in March 2017, the FRCB assumed responsibility for retail sales in the Lobby of the F. Scott Fitzgerald Theatre before and during ballet performances. FRCB now conducts a Bake Sale for ballet audiences, with pre-wrapped food and drinks provided by participating families. In addition, a Flower Sale sells flowers obtained commercially, offering free on-stage delivery of flowers to dancers. Periodically, the FRCB may sell FRCB-branded merchandise, conduct raffles of donated items or include a Craft Sale. Sales in the lobby of the F. Scott Fitzgerald theater during performances produced gross income of \$4682, or 37.3% of unrestricted gross income. An invoice for craft-sale Cost of Goods Sold, which was received after 2017 fiscal year-end and paid in Fiscal 2018, is recognized as an Accrued Liability. Revenues received through retail offerings are regarded as sales at market prices rather than charitable contributions.




GOFUNDME CAMPAIGN

During 2017, the FRCB launched a GoFundMe campaign which solicits crowd-funding to support the Rock-ville Civic Ballet's rebuilding of a stage set used in its annual production of *The Nutcracker*. Since set costs exceeded fundraising, the online GoFundMe campaign remains active on an ongoing basis. In Fiscal 2017, the FRCB received \$737 in GoFundMe pledges net of transaction fees, comprising 5.9% of unrestricted gross income. Funding obtained through the GoFundMe campaign were treated as donor-restricted capital until it was reclassified after program expenditures exceeded the contributions. Uses of Funds

GENERAL AND ADMINISTRATIVE

General and Administrative costs in 2017 totaled \$1364 or 10.9% of unrestricted gross income. Certain one-time expenditures related to initiating operations of the FRCB materially affected general and administrative costs in 2017. Specific contributions were solicited from key FRCB members to fund defined start-up costs.



PROGRAM FUNDING

Program expenditures in support of the FRCB charitable mission totaled \$3250 for 2017, or 25.9% of unrestricted gross income.

PROGRAM 1: THE NUTCRACKER SET

One major program was approved by the FRCB Board during 2017, financially supporting the renewal and reconstruction of the first-act set for the annual production of *The Nutcracker* by the Rockville Civic Ballet. In 2000, the Rockville Civic Ballet created a substantial set depicting a full-stage interior view of an opulent home which was used each year for the "Party Scene". In 2015, many components of the set were destroyed or damaged in storage, limiting the on-stage effect of the remaining set elements. In 2017, the FRCB agreed to sponsor the efforts of the Rockville Civic Ballet, with the City of Rockville Department of Recreation and Parks, to rebuild the set. Specifically, the FRCB agreed to pay Bill Presley, the designer and builder of the original 2000 first-act set, to redesign and rebuild new set components. Mr. Presley incorporated features im-

proving the safety and portability of the new set, providing a complete set of documentation and instructions for use of the new set. Design and construction of the new set was completed in time for use in the Rockville Civic Ballet's 2017 production of *The Nutcracker*, with six shows which opened on 2 December 2017. Disbursements for this program during Fiscal 2017 totaled \$2500, comprising 19.9% of unrestricted gross income.

PROGRAM 2: DANCER HONORARIA

The FRCB Board approved an ongoing program of dancer recognition in the form of honoraria intended to defray some costs of participation in performances of the Rockville Civic Ballet. During Fiscal 2017, dancer honoraria totaled \$750, or 6.0% of unrestricted gross income.

INCREASE IN NET ASSETS

Net Assets of \$8427 were retained in the form of cash deposited in bank accounts at Fiscal 2017 year-end with \$7927 being unrestricted, representing 63.2% of unrestricted gross income. In addition, \$1333 in unrestricted cash was reserved to pay the Accrued Liability invoice. A donor-restricted contribution of \$500 was segregated in a separate savings account, with earned interest of \$2.47 retained for compounding purposes as of the end of the 2017 Fiscal Year.

These financial statements are unaudited and subject to revision. An Audit Sub-committee began work on protocols for auditing FRCB books. An Audit Committee Report will be submitted to the FRCB Board of Directors during 2018.
